- The above Unaudited Financial Results have been reviewed by the Audit Committee and approved by the Board of Directors at their respective meetings held on 13 August, 2018. The Statutory Auditors have also carried out a Limited Review of the unaudited results for the quarter ended 30 June, 2018.
- 2. As the Company has only one operating segment, disclosure under Ind AS 108 on "Operating Segments" is not applicable.
- 3. The figures for the preceding quarter ended 31 March, 2018 are the balancing figures between audited figures in respect of the full financial year and the year to date figures upto the third quarter.
- 4. Ind AS 115, Revenue from Contract with customers is effective from accounting period beginning on or after 1 April, 2018, accordingly the Company has applied Ind AS 115 as on the transition date of 1 April, 2018. The Company has applied modified retrospective approach to its real estate projects that were not completed as at 1 April, 2018, accordingly profit recognised on such projects uptill 31 March, 2018, as per the existing revenue recognition standards has been de-recognised and debited to retained earnings as at 1 April, 2018. The comparatives have not been restated and hence the current period figures are not comparable to the previous period figures. Due to application of Ind AS in current quarter, revenue from operations is higher by Rs. 3,541.62 lakhs, and loss after tax is lower by Rs. 1,240.70 lakhs, than it would have been if the replaced standards were applicable. The basic and diluted EPS for the period is Rs. (0.62) per share instead of Rs. (0.90) per share.
- 5. Figures for the previous quarter / year have been regrouped, wherever necessary, for the purpose of comparison.
