During the Financial Year 2010-11, the Company allotted 1,90,38,113 (One Crore Ninety Lacs Thirty Eight Thousand One Hundred Thirteen Only) Equity Shares of ₹10/- (Rupees Ten only) each on Qualified Institutions Placement (QIP) basis on October 12, 2010. Consequently, the Paid-up Share Capital of the Company has increased from ₹198,55,24,720/- (Rupees One Hundred Ninety Eight Crores Fifty Five Lacs Twenty Four Thousand Seven Hundred Twenty only) to ₹217,59,05,850/- (Rupees Two Hundred Twenty only) to ₹217,59,05,850/- (Rupees Twenty only) to ₹217,50/- (Rupees Twenty only) to ₹217,50/- (Rupees Twenty only) to ₹217,50/- (Rupees Seventeen Crores Fifty Nine Lacs Five Thousand Eight Hundred Fifty only)

Subsequently, the Company sub-divided its each existing Equity Share having face value of ₹10/-(Rupees Ten Only) into 2 (Two) Equity Shares having face value of ₹5/- (Rupees Five only) each fully paid-up w. e. f. October 19, 2010, being the record date for the said purpose. Accordingly, the present structure of Paid- up Share Capital of the Company is ₹217,59,05,850/- (Rupees Two Hundred Seventeen Crores Fifty Nine Lacs Five Thousand Eight Hundred Fifty only) consisting of 43,51,81,170 (Forty Three Crores Fifty One Lacs Eighty One Thousand One Hundred Seventy only) Equity Shares of ₹5/- (Rupees Five only) each.

No record date was fixed for the purpose of dividend as the same was not declared for the Financial Year 2009-10
