<u>Subject: Summary of Proceedings of the 30th Annual General Meeting ("AGM") of the Members of Parsynath Developers Limited ("the Company")</u>

Pursuant to Regulation 30 read with Para A of Part A (13) of Schedule III to the Securities and Exchange Board of India (Listing Obligations and Disclosure Requirements) Regulations, 2015 ("Listing Regulations"), we wish to inform you that the 30th Annual General Meeting ("AGM") of the Members of the Company was duly convened on Thursday, September 30, 2021 at 11:30 a.m. and was conducted through Video Conferencing ("VC")/ Other Audio Visual Means ("OAVM").

Mr. Mandan Mishra, Company Secretary, welcomed the Members, Directors, CFO and Auditors of the Company and introduced the Panelists. He informed that the Company had taken the requisite steps to enable Members to participate and vote on the items considered at the AGM.

As per the shareholders log-in data available, the requisite quorum being present, Mr. Pradeep Kumar Jain, Chairman of the Company, called the meeting to order and delivered his speech informing, *inter-alia*, about the Company's performance, outlook and way forward.

The Company Secretary took over the proceedings and informed the members regarding participation in this meeting through VC / OAVM, remote e-voting and e-voting provided during the Meeting. The relevant documents, in terms of the requirements of Companies Act, 2013, were made available for electronic inspection during AGM.

Thereafter, the observations made/ matters of emphasis by the Secretarial Auditors and the Independent Auditors in their respective Reports were read out by the Company Secretary.

He requested the Chairman to take up the business of the Meeting, as mentioned in the Notice.

As the Notice of the Meeting had already been circulated / made available on the Company's website, the same was taken as read.

Further, pursuant to Regulation 44(3) of the Listing Regulations, the details regarding the voting results shall be submitted within the prescribed time, upon receipt of Scrutinizer's Report and shall also be placed on the website of the Company and of the e-voting agency.
